

THE NATIONAL HUG DAY WITH HUGGIES SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The National Hug Day With Huggies Sweepstakes ("Sweepstakes") is sponsored by Kimberly-Clark Corporation ("Sponsor"), 2100 Winchester Road, Neenah, WI 54956 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on January 15, 2021 at 12:00 PM Eastern Time ("ET") and ends on February 15, 2021 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

 - A. **Online:** During the Sweepstakes Period, an eligible entrant may visit Huggieshugday.com ("Website") and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Entrant must then follow the on-screen prompts to upload a photo of entrant hugging his/her baby. **All photos must comply with the restrictions outlined below.** Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes.
 - B. **Instagram:** An entrant must follow the steps below to receive an entry into the Sweepstakes:
 - i. Sign into his/her Instagram account (entrant may create an Instagram account for free if he/she does not already have one);
 - ii. Become a follower of @Huggies on Instagram (if not already following @Huggies). There is no charge to sign up for Instagram or to follow @Huggies; and
 - iii. Compose a new Instagram post sharing photo of entrant hugging his/her baby, including the hashtag "#HuggiesHugDaySweepstakes" and tag @Huggies to receive one (1) entry into the Sweepstakes.

C. Twitter: An entrant must follow the steps below to receive an entry into the Sweepstakes:

- i. Sign into his/her Twitter account (entrant may create a Twitter account for free if he/she does not already have one);
- ii. Become a follower of @Huggies on Twitter (if not already following @Huggies). There is no charge to sign up for Twitter or to follow @Huggies; and
- iii. Compose a new Tweet sharing photo of entrant hugging his/her baby, including the hashtag “#HuggiesHugDaySweepstakes” and tag @Huggies to receive one (1) entry into the Sweepstakes.

The content included in the entry will not be judged or used in any way to determine a winner. By entering the Sweepstakes and using the hashtag “#HuggiesHugDaySweepstakes”, entrant hereby agrees to be bound by these Official Rules. Entries will be deemed made by the authorized account holder of the Twitter or Instagram account the entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Twitter account or Instagram by the online service provider. An entrant must have a non-private Twitter account or Instagram account to enter the Sweepstakes and must be a follower of @Huggies on the platform used to enter until March 15, 2021 for potential winner notification purposes to be eligible to win/claim a prize. If an entrant does not have a non-private Twitter account, he/she can create one at no cost by visiting www.twitter.com. Please note that an entrant must agree to comply with the Twitter Terms of Service (<https://twitter.com/tos/>) and Privacy Policy (<https://twitter.com/privacy>) (if entering using Twitter) in order to participate in the Sweepstakes. Due to the way Instagram operate its services, entries from users with protected or private accounts (i.e., entrant has set his/her account so that only people the entrant has approved can view his or her updates) may not be received. If an entrant enters from his/her wireless phone, the entrant’s wireless service provider may charge the entrant. Entrants should consult their wireless-service providers regarding their pricing plans. Message and data rates may apply. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Twitter or Instagram.

- Entry must be in one of the following formats: .JPEG, .JPG, .GIF, or .PNG and must not exceed 10 MB if submitted online;

- Entry must be in English (except for commonly understood foreign words);

- Entry must be suitable for publication (i.e., may not be obscene or indecent);
- Entry cannot contain trademarks, logos or trade dress owned by any third party, or advertise or promote any brand or product of any kind, other than the Sponsor’s;
- Entry cannot contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art or images);

- Entry cannot include the name, likeness, photograph, or other indicia identifying any person, living or dead, without written permission from that person (or persons parent or legal guardian if person is a minor);
- Entry cannot be sexually explicit or suggestive, violent or derogatory of any ethnic, racial, gender, religious, professional or age group;
- Entry cannot promote illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message;

RANDOM DRAWING: On or around February 16, 2021, the Administrator will randomly select twenty-five (25) potential grand prize winners and one hundred (100) potential first prize winners from all eligible entries received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

A. Grand Prizes (25): Each grand prize is a \$500 Gift Card (determined by Sponsor in its sole discretion) (each a "Grand Prize"). No more than twenty-five (25) Grand Prizes will be available in the Sweepstakes. The ARV of each Grand Prize is \$500.

- B. First Prizes (100):** Each first prize is a \$100 Gift Card (determined by Sponsor in its sole discretion) (each a “First Prize”). No more than one hundred (100) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$100.
- C. Total ARV:** The total ARV of all prizes is \$22,500.
- D. Odds of Winning:** The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.
- E. General Conditions:** There is a limit of one (1) prize per person. In no event will more than twenty-five (25) Grand Prizes and one hundred (100) First Prizes, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

The use of a gift card is subject to the terms and conditions set forth thereon which shall govern the use of the gift card. HOW TO CLAIM A PRIZE:** The potential winners are subject to verification of eligibility and compliance with these Official Rules After the random drawing, Administrator will notify the potential winner via either e-mail at the e-mail address provided at the time of registration, or on either Twitter or Instagram by a Direct Message from @Huggies (depending on his/her method of entry) with instructions on how to claim his/her prize. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner’s right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, the respective prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate Winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Upon verification of eligibility, the prizes will be e-mailed to the winners at the e-mail addresses provided at the time of entry. Any portion of a prize not accepted by winner will be forfeited. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner’s privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
